

Cricket League of New Jersey

Registration For Membership - Season 2012



The Cricket League of New Jersey (CLNJ) is a non-profit organization, established in 2000. CLNJ vision is to become the best league for playing cricket and for all its stakeholders, including the players & umpires, their families, spectators, the city/county officials, suppliers and the national organization representing USA.

Clubs interested in playing in the CLNJ must complete this Registration Form accurately and completely and submit it to the secretary. The Applicant Club must meet ALL requirements as set forth in the following sections. All documents required by this application must be submitted along with the completed application form. The Executive Committee of CLNJ will review the application and notify the Applicant Club Officers of their decision thereafter.

NOTE: Minimum Eligibility Requirements:

1. **All Applicant Clubs must fill and submit the Registration Form for Season 2012.**
2. **Registration Form/Fee Due at the FIRST AGM for the existing teams and Due-Date for the new Teams/Clubs is February 28th, 2012. Registration Form received after the deadline may not be accepted.**
3. **The Registration Form must be read and signed (on the last page) by 3 representative officers of the club.**
4. The Registration Form must be filled out accurately and completely.
5. The Applicant Club must have a playing roster of at least 15 members. The Club Roster must be submitted along with the application.
6. If the Applicant Club has access to a Playing Facility, Documented evidence (Copy) of ground permit must be submitted along with the application.
7. The Applicant Club must own all cricket equipment necessary to host a match, for example matting, stumps, bails, field-markers etc.
8. Any information that cannot be completed before the deadline should be sent by March 21st 2012.
9. The Annual Membership Fees comprises of the following components.
 - a. **League Fees:** The CLNJ Annual Fees for the Season is **\$650.00** for the continuing member clubs and **\$900.00** for the new clubs (new clubs are those which did not take part in the 2011 season). This will be utilized for the purchase of cricket balls, Insurance and other administrative duties. The League Fees must be submitted along with the application. Teams that do not have a home ground need to pay an additional amount of \$300 (i.e. New teams without a home ground will need to submit \$1200 and existing teams without a ground will need to submit \$950. See Ground fee section for more details on this). **Make the check Payable to CLNJ.**
 - b. **Umpiring Fees:** The umpiring fee for the season has been set at \$45 per team per game. For games with 2 league umpires, each umpire gets paid \$45 by each team for a total of \$90 per umpire. A team is required to pay the amount directly to the umpire before the start of the game. *The umpires' fee is higher if the game is played at a location where the umpire has to travel a long distance – please refer to the CLNJ by-laws for the same.*
 - c. **Ground Fees:** The ground fee for the season has been set at \$40 per team per home game (Ground fees will be different for certain grounds based on their ground permit) for a team without a Home ground. Teams without a home ground are required to pay this amount to the Treasurer as part of the league fee (Each team is expected to host atleast eight games).
